SECOND MODIFICATION OF STANDING ORDER REGARDING CORONAVIRUS DISEASE (COVID-19) MITIGATION TO ALL FRIO COUNTY JUSTICES OF THE PEACE (JUSTICE COURT)


1. The Justices of the Peace in Frio County issue this order pursuant by the authority granted by law and by all emergency orders regarding he COVID-19 state of disaster issued by the Supreme Court of Texas of Criminal Appeals of Texas. This order is in response to the "EIGHTH EMERGENCY ORDER REGARDING THE COVID-19 STATE OF DISASTER' by the Supreme Court of Texas regarding deadlines for the filing of service of civil cases.
2. This order amends "TEMPORARY STANDING ORDER REGARDING CORONAVIRUS DISEASE (COVID-19) MITIGATION TO ALL FRIO COUNTY JUSTICES OF THE PEACE (JUSTICE COURT) UPDATED MARCH 18, 2020" and "MODIFICATION TO STANDING ORDER REGARDING CORONAVIRUS DISEASE (COVID-19) MITIGATION TO ALL FRIO COUNTY JUSTICES OF THE PEACE (JUSTICE COURT) EVICTIONS".
 - a. Any deadline for the filing (including statue of limitations calculations) or service of any civil case (except a case for residential eviction for threat to a person as described in the "TEMPORARY STANDING ORDER REGARDING CORONAVIRUS DISEASE (COVID-19) MITIGATION TO ALL FRIO COUNTY JUSTICES OF THE PEACE (JUSTICE COURT) (ORDER NO. 1)" and "MODIFICATION TO STANDING ORDER REGARDING CORONAVIRUS DISEASE (COVID-19) MITIGATION TO ALL FRIO COUNTY JUSTICES OF THE PEACE (JUSTICE COURT) EVICTIONS" is tolled from **March 13, 2020 until June 1, 2020**.
 - b. Any deadline for perfecting appeal or for other appellate proceedings (except in a case for residential eviction for threat to a person as described in the "STANDING ORDER REGARDING CORONAVIRUS DISEASE (COVID-19) MITIGATION TO ALL FRIO COUNTY JUSTICES OF THE PEACE (JUSTICE COURT) (ORDER NO. 2)" IS TOLLED FROM **MARCH 19, 2020 TO MAY 8, 2020**.

- c. To include Sheriff Officers paragraph 6 of the "TEMPORARY STANDING ORDER REGARDING CORONAVIRUS DISEASE (COVID-19) MITIGATION TO ALL FRIO COUNTY JUSTICES OF THE PEACE (JUSTICE COURT) (ORDER NO.1)" and paragraph 4 of the "MODIFICATION TO STANDING ORDER REGARDING CORONAVIRUS DISEASE (COVID-19) MITIGATION TO ALL FRIO COUNTY JUSTICES OF THE PEACE (JUSTICE COURT) EVICTIONS"

This order is in effect immediately.

The time periods in this order may be extended in a subsequent order if required.
