


- 1. On Tuesday 10/31/23 at approximately 9:20 p.m. Deputy Paiz with the San Patricio County Sheriff's Department was sent to the area of FM 631 and Hwy 188 in Taft Texas 78390 for a call of a Horse in the road.
- 2. On the way Deputy Paiz located the Horse at the intersection of FM 631 and CR 1258. Deputy Paiz noticed the horse was trying to get in a fenced in area where there were other horses. Deputy Paiz went to the house that was connected to the property, which was 8862 CR 1258 to see if he could make contact with anyone.




