A tax rate of \$.495156 per \$100 valuation has been proposed by the governing body of San Patricio County.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for San Patricio County from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval tax rate is the highest tax rate that San Patricio County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that San Patricio County is not proposing to increase property taxes for the 2020 tax year.

A public meeting on the proposed tax rate will be held on August 31, 2020 at 9:00 AM at San Patricio County Commissioner's Courtroom.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, San Patricio County is not required to hold an election at which voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Commissioner's Court of San Patricio County at their offices or by attending the public meeting mentioned above.
