Notice is hereby given that an Emergency Special Called Meeting of the above named Commissioners Court will be held on the **22nd** day of **April 2025**, at **3:30 p.m.**, in the Frio County Courthouse, Pearsall, Texas. An emergency or urgent public necessity exists that requires immediate action by the Frio County Commissioners Court or an imminent threat to public health and safety or a reasonably unforeseeable situation exists, as follows:

On April 14, 2025, a fire was set in the Frio County Dilley Annex Building located at 101 N. Commerce Street in Dilley, Texas. The fire caused damage to the building which will result in the building being unoccupied for a few months as remediation and repairs are completed. Emergency remodeling of the building owned by Frio County Located at 124 E. Leona Street in Dilley, Texas must be completed as soon as possible to mitigate any disruptions to services Frio County provides to its constituents. As such, an emergency or urgent public necessity exists that requires immediate action as a reasonably unforeseen situation occurred due to said fire.


