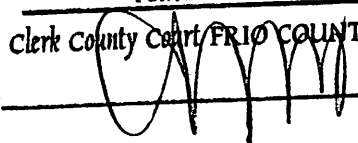
Hon. Mario Martinez

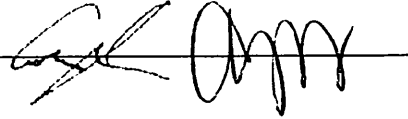
