If the judge rules in favor of the Plaintiff on **Evictions** you may appeal within **5** days or move out by midnight on the 5<sup>th</sup>. Day after judgment. The landlord may file a Writ of Possession the next morning only if an appeal has not been filed. The appeal for all other Claims is **21** days or **7** days if filing Appeal by Affidavit of Inability to Post Bond.
