
TO ALL THE REGISTERED VOTERS OF THE CHARLOTTE INDEPENDENT SCHOOL DISTRICT:

Notice is hereby given that an election shall be held on the 6th day of November, 2018, a uniform election date, in the Charlotte Independent School District (the "District") for the purpose of conducting a bond election (the "Election").

<u>Bond Election – Official Proposition</u>. The District will hold this Election for the purpose of determining whether the Board of Trustees of the District shall be authorized to issue bonds of the District in the amount and for the purposes identified below, at which Election the following Proposition shall be submitted in accordance with law:

### **PROPOSITION**

OF TRUSTEES OF CHARLOTTE "SHALL THE BOARD INDEPENDENT SCHOOL DISTRICT BE AUTHORIZED TO ISSUE AND SELL AT ANY PRICE OR PRICES THE BONDS OF THE DISTRICT IN THE PRINCIPAL AMOUNT NOT TO EXCEED \$5,000,000.00 FOR THE CONSTRUCTION, RENOVATION, ACQUISITION, AND EQUIPMENT OF SCHOOL BUILDINGS IN THE DISTRICT, AND THE PURCHASE OF THE NECESSARY SITES THEREFOR, WHICH BONDS MAY BE ISSUED IN VARIOUS ISSUES OR SERIES, SHALL MATURE SERIALLY OR OTHERWISE NOT MORE THAN 40 YEARS FROM THEIR DATE, AND SHALL BEAR INTEREST AT SUCH RATE OR RATES (FIXED, FLOATING, VARIABLE, OR OTHERWISE), NOT TO **EXCEED** THE **MAXIMUM** RATE NOW OR HEREAFTER AUTHORIZED BY LAW, AS SHALL BE DETERMINED BY THE BOARD OF TRUSTEES OF THE DISTRICT WITHIN THE DISCRETION OF THE BOARD AT THE TIME OF ISSUANCE; AND SHALL THE BOARD OF TRUSTEES BE AUTHORIZED TO LEVY AND PLEDGE, AND CAUSE TO BE ASSESSED AND COLLECTED, ANNUAL AD VALOREM TAXES ON ALL TAXABLE PROPERTY IN THE DISTRICT SUFFICIENT, WITHOUT LIMIT AS TO RATE OR AMOUNT, TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS AND THE **OF** ANY CREDIT AGREEMENTS EXECUTED COSTS CONNECTION WITH THE BONDS?"



Form of Ballot for the Election. The official ballot for the Election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote "FOR" OR "AGAINST" the aforesaid PROPOSITION, with the ballot to contain such provisions, markings, and language as required by law, and with such PROPOSITION to be expressed substantially, as follows:

### **PROPOSITION**

"THE ISSUANCE OF AN AMOUNT NOT TO EXCEED \$5,000,000.00 SCHOOL BUILDING BONDS FOR THE CONSTRUCTION, RENOVATION, ACQUISITION, AND EQUIPMENT OF SCHOOL BUILDINGS IN THE DISTRICT, AND THE PURCHASE OF THE NECESSARY SITES THEREFOR, AND THE LEVYING OF A TAX IN PAYMENT THEREOF."

### **Election Day Date and Times**

Election Day Voting in the District shall be conducted on the 6th day of November, 2018, between the hours of 7:00 a.m. and 7:00 p.m. at the polling location for their respective County Election Precincts as shown on Exhibit "A", attached hereto. All eligible voters of the District may vote in the Election.

### Early Voting By Personal Appearance Dates and Times

Early Voting shall begin on Monday, October 22, 2018, and continue through Friday, November 2, 2018. Early Voting by personal appearance shall be held at the locations, dates and times as shown on Exhibit "A", attached hereto. All eligible voters of the District may vote at the early voting locations during the Early Voting of the Election.
