The Commissioners and the Judge discussed closing the Frio County Courthouse due to a sudden increase in positive cases amongst the Frio County Courthouse staff, and the possibility that several offices had been exposed unknowingly by said individuals. The Commissioners eventually decided on the following

ALL COUNTY OFFICES (including offsite offices)

- **Access only for necessary and emergency business by appointment only as to be determined by the elected officials**
- **Department heads determine staffing as needed, taking into consideration the safety of the public and anyone on premises**
- **Encourage temperature taking, in addition to the regular mask wearing and social distancing safety measures**
