**RESOLUTION**

**A RESOLUTION OF THE COMMISSIONERS COURT OF FRIO COUNTY, TEXAS, THAT FRIO COUNTY WILL ENACT AND MAINTAIN ADEQUATE FLOODPLAIN MANAGEMENT STANDARDS THROUGHOUT FRIO COUNTY, AND RESOLUTION APPOINTING A FLOODPLAIN ADMINISTRATOR.**

**WHEREAS**, certain areas of Frio County are subject to periodic flooding, causing serious damages to properties within these areas; and

**WHEREAS**, under the National Flood Insurance act of 1968, as amended, residents of Frio County can purchase Federally subsidized flood insurance if the County qualifies for, and participates in the National Flood Insurance Program; and

**WHEREAS**, it is the intent of this Commissioners Court to qualify for participation in the National Flood Insurance Program and to require the recognition and evaluation of flood hazards for all proposed developments within the identified floodplains of Frio County; and

**WHEREAS**, the Commissioners Court of Frio County has the legal authority to adopt and enforce floodplain management criteria to reduce future flood losses pursuant to Subchapter 1, Section 16.315 of the Texas Water Code;

NOW, THEREFORE, BE IT RESOLVED, that this Commissioners Court hereby:

1. Assures the Federal Emergency Management Agency it will enact as necessary, and maintain in force in those areas having flood hazards, adequate floodplain management standards with effective enforcement provisions consistent with the minimum criteria set forth in Section 60.3 of the National Flood Insurance Program Regulations; and
2. Vests the County Judge with the responsibility, authority, and means to:
  - a. Assist the Administrator, at his request, in his delineation of the limits of the areas having special flood hazards.
  - b. Provide such information as the Administrator may request concerning present uses and occupancy of the floodplain.
  - c. Cooperate with Federal, State and local agencies and private firms which undertake to study, survey, map, and identify floodplain areas, and cooperate with neighboring political subdivisions with respect to management of adjoining floodplain areas in order to prevent aggravation of existing flood hazards.
  - d. Submit on as requested by, the Administrator, a biennial report to the Administrator on the progress made during the past year within the County in the development and implementation of floodplain management measures.
  - e. Upon occurrence, notify the Administrator in writing whenever a community incorporates


and the County no longer has authority to enforce floodplain management measures within the newly established corporate limits. If possible, include within such notification a copy of the County's flood hazard boundary map clearly delineating the new corporate limits and provide a mailing address for the newly incorporated city.


3. Appoints Ray Kalio, Frio County Floodplain Administrator, to maintain for public inspection and to furnish upon request, any certificates of flood-proofing, and information on the elevation (in relation to mean sea level) of the level of the lowest habitable floor of all new and substantially improved structures located within the identified floodplain of Frio County. The information should include whether or not such structures contain a basement, the elevation of the basement, and if the structure has been flood-proofed, the elevation to which the structure was flood-proofed.

**NOW, THEREFORE, BE IT RESOLVED** by the Commissioners Court of the County of Frio, Texas at its special called meeting, duly, with a quorum present at the Frio County Commissioners Courtroom, Frio County Courthouse, Pearsall, Texas, that Frio County will enact as necessary, and will maintain adequate floodplain management standards.


